Winter 2017 Legislative Reception Recap

EACC had out annual Legislative Reception o December 15, 2016, at Somers Middle School. It was well attended by many of our reps, and many of our elected officials. State Senator Mac Middleton and Delegate Edith Patterson attended. Commissioner President Peter Murphy and Commissioner Ken Robinson were also there. We had the majority of our Board of Education at the reception: Board of Ed Chairman Ginny McGraw, Board Vice-Chair Mike Lukas, and Board members Jennifer Abell, Vicki Kelly and Mike Crawford. Sheriff Berry joined us and answered some questions.

Our Government Relations committee, chaired by Veronica McFadden, did an outstanding job of coming up with questions for our guests. The elected officials had plenty of time to answer the questions and give us feedback. There was time after the program for our reps to speak with them in a more informal, one on one conversation style with their additional questions.

Here are some of the highlights of the questions and answers from the evening. If you would be interested in hearing a complete recap, please contact Veronica McFadden, GR chair, or Linda McLaughlin, EACC President.

- Senator Middleton and Delegate Patterson were asked questions about mentorship programs for new and midcareer teachers, violence in schools, and the BOOST bill (diverting taxpayer dollars to subsidize private schools), ESSA implementation, continuation of the current Maryland charter school law, and earned sick leave.
 Both Senator Middleton and Delegate Patterson them liked the idea of the first year mentorship and hope the model will be used statewide.
- Both of them said they would support a bill that would place violence against teachers in the same status as violence against other public servants, such as firefighters and police officers.

- Senator Middle said that he would support BOOST <u>ONLY IF</u> there is a full commitment/full funding of public education. Delegate Patterson opposes BOOST- every public dollar should go to public schools.
- Both said they would support us and help pass legislation that prevents Hogan's State Board of Education from using the Every Student Succeeds Act or any new Trump education initiative to close public schools, convert them into private or charter schools, or allow forprofit corporations to receive public taxpayer dollars.

Commissioner President Peter Murphy and Commissioner Ken Robinson were asked questions about budget and funding shortages, recruitment and retention, and whether writing letters or showing up at hearings makes a difference to the Commissioners.

- Commissioner President Peter Murphy said that we cannot recover the revenue for lost steps, that they need our help determining what the greatest need is for our students in the growing special needs populations, and that Charles County is growing in part because of the reputation of our school system
- Commissioner Robinson talked about the quality of life here and the need to continuing to renovate schools
- Both commissioners said that they would like to hear from us more, with suggestions and solutions

Our Board of Education members were asked questions about teacher retention, Teacher Town Halls, and discipline.

- Board Chair Ginny McGraw noted that we need to look at salary scales, that we need resources, and that they know we have problems getting enough subs
- Board Vice-Chair Mike Lukas said that the teacher retention problem is everywhere, and that we want Charles County

to be "the option" in the Southern Maryland/Washington area

- Board member Mark Crawford discussed that stress is one of the main factors why people leave the profession
- The Board of Ed plans to have another er Teacher Town Hall to hear educator concerns, hopefully in February (date to be determined)
- All the Board members present were concerned about discipline in our classrooms. Board member Vicki Kelly spoke about keeping parents involved in the process, and supporting our SROs and the relationship with the sheriff's department.
- Our Board would like to hear from anyone who has ideas and feedback.

Sheriff Berry was asked some questions about school safety, programs for the education of parents and educators on social media, and the increased rates of harassment and violence against students following the most recent presidential election. He said,

"This is America- we are seeing freedom of choice and the transference of power. We do not condone violence of any sort in our community. We have more similarities than we have differences. We must be responsive. We must tell our young people, "This will be okay." We must urge young people to get involved in the political process, and put their energy in a positive place."

It was a very interesting and instructional reception. We appreciate the time that our elected officials took to attend and answer our questions, and thank you to our reps and members who attended as well.

New Election, New Year, New Challenges

As we look toward the rest of case relating to unions and 2017 with a new administration in Washington, DC, we quickly realize there will be some new (and some not so new) challenges for public education over the next 4-8 years.

With the new Administration, we have seen and heard numerous remarks about public education, including the nomination of a new Secretary of Education. All of his comments so far portend four of the most challenging years for public education on fronts as wide-ranging as charter schools, Title I funding, vouch- split government with a Govers, Common Core, etc. This could mean a minimum of four years of confusion as we embark on the implementation of the federal Every Student Succeeds Act (ESSA), which in its reauthorization replaces the Race to the Top (RTTT) program under the outgoing Administration.

As an association, NEA/MSEA/ EACC has seen legislation passed in other states that have hindered the Association's mission to advocate for its members and promote public education. Most recently, we saw an eightmember US Supreme Court deadlock on an important

agency fee that is sure to come back in a different form. This new Administration will very likely have at least two Supreme Court nominations to make that will greatly shape the US Supreme Court bench for years to come. Further, this Administration will also have appointments to the National Labor Relations Board (NLRB) that will greatly shape the body of regulations that impact how unions operate.

On the State level we have a ernor who has withheld money intended to fund public education twice, has implemented a plan to fund students school tuition with public tax dollars this year for the first time, wants to overhaul Maryland's charter school law to allow for more profiteering, and has overruled local autonomy by dictating the school calendar will begin after Labor Day. This latest act flies in the face of a considerable body of research that says students need more instructional time and longer school years – not less – to improve student achievement and meet an ever-growing

testing regimen.

With all of these challenges on the road ahead, educators, advocates, stakeholders, should take heed to the changing landscape and seek to understand how public is being affected. With the election over, where will all of these issues play out over the coming years... in our schools and local boards of education meetings; in our county councils and commissioner' chambers, and in our statehouses and legislatures. With an eye toward the allimportant 2018 statewide elections in Maryland and mid-term Congressional elections, there is plenty for everyone to do. We must begin by engaging our colleagues on why they MUST get involved in their Association. Inform our friends and family on why they are needed as advocates for public education. And why we MUST make our voices heard. The road ahead may look daunting, but there are plenty of opportunities we can also take advantage of. Your Association is only as strong as its members. Be the voice for public education, for educators, and for students.

What To Do After Your Interim SLO Review

At the SLO interim review with your principal, you had the opportunity to discuss your concerns with your SLOs and make changes to the target and student scope. After the review, you had several weeks before post testing to work with students and help them realize the academic gains you projected. In the next few weeks your SLO will be scored. If you don't make your target, reflect on the key SLO elements that have been proven to increase student growth:

Data review and baseline evidence:

 What data are you collecting on a regular basis to monitor student growth? What is that data telling you about your students' progress?

Student Population:

- How has your student population changed?
- Even though new students after September 30 will not be included in your SLOs, have new students or withdrawals changed the culture of your classroom and/or your teaching methods? If yes, how has this affected student progress toward the SLO targets?

Instructional Strategies:

- Have you implemented the identified strategies in your classroom as planned? With fidelity?
- If they are not working to increase student achievement, are there oth-

er strategies you can use to help your students make the gains you need to make your SLO target?

SLOs, when used as intended, lead to better instruction and increased student growth. Think about your SLOs as more than numbers on an evaluation. If you do, you should have no trouble exceeding your targets next year.
